1. BACKGROUND

The Harry Gwala Development Agency (HGDA) is responsible for implementing infrastructure and development projects within the Harry Gwala District. The existing driveway located at the HGDA premises at the main gate has deteriorated over time due to constant vehicular movement and weather exposure. The current condition has resulted in surface damage and drainage challenges, making it necessary to rehabilitate the affected section.

The Agency therefore seeks the services of a qualified and experienced contractor to rehabilitate a 63.5-metre-long and 7.7-metre-wide section of the driveway at the main gate.

2. PURPOSE AND OBJECTIVE

The purpose and objective of this project is to rehabilitate and restore the specified section of the driveway to a durable and safe standard that improves access, enhances appearance, and ensures long-term sustainability.

3. DETAILED SCOPE OF WORK

The appointed service provider will be required to perform the following tasks:

3.1 Site Preparation

- a. Conduct a detailed site assessment to confirm measurements and identify the extent of deterioration.
- b. Remove existing damaged surfacing materials and debris.
- c. Protect existing infrastructure during work.

3.2 Excavation and Sub-base Works

- a. Excavate and compact the existing base to the required depth.
- b. Supply and place suitable sub-base material (e.g., G5 material) and compact to engineering standards.
- c. Ensure appropriate drainage falls and slopes are maintained.

3.3 Base and Surface Layer Construction

- a. Supply and place the base course.
- b. Compact to achieve the required density.
- c. Provide an approved surfacing layer — asphalt, (to be approved by HGDA's Project Manager).
- d. Ensure a smooth and even surface finish.

3.4 Drainage and Finishing Works

- a. Reinstate or construct side drains and edge restraints.
- b. Ensure proper stormwater management to prevent future erosion or pooling.
- c. Reinstate any disturbed areas adjacent to the rehabilitated driveway.

3.5 Quality Control and Reporting

- a. Conduct compaction and material testing in accordance with SANS and Municipal engineering standards.
- b. Maintain quality control throughout the project.
- c. Submit a completion report including test results, as-built measurements, and before-and-after photographs.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“Rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
